

## 1. Stakeholder Engagement

### 1.1. Key points:

- The Combined Authority cannot deliver the City Region ambitions in isolation. If the target is to be achieved all elements of society will need to come together and work in collaboration.
- Extensive engagement with stakeholders is planned as part of the Emission Reduction Pathways commission. This includes:
  - Four sector-specific workshops focussed on providing feedback on the results of the pathways and gaining input into the policy recommendations. The workshops will be open to many stakeholders, including those from civil society. Provisionally scheduled for April 2020.
  - Public consultation via the Combined Authority's Your Voice platform focussed on seeking input on the draft outputs. Any interested party will have the opportunity to provide comments and time has been incorporated into the work programme to consider and amend the outputs where necessary. Provisionally scheduled for June 2020.
  - Dissemination of information and seeking feedback via public meetings e.g. Transport Committee, Green Economy Panel, LEP Board. All information provided to these meetings will be available for the general public to review and scrutinise.
