
4. **Land** - Any beneficial interest in land⁷ which is within the area of the WYCA



The definition of "director" includes a member of a committee of management of an industrial and provident society, and "securities" means share, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

⁷ "Land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income.

5. **Licences** - Any licence (alone or jointly with others) to occupy land in the area of the WYCA for a month or longer.
