See Annex 4 – Members' Code of Conduct

One of the categories of disclosable pecuniary interest is "Employment, office, trade, profession or vocation carried on for profit or gain". An allowance you receive for an office held in any local authority gives rise to a disclosable pecuniary interest; this includes any office you hold in your own local authority, at WYCA, a district, parish or town council, or the fire and rescue authority. (For example: the basic allowance you receive as a member of your own Council is a disclosable pecuniary interest.)

To enable you to participate in any discussion and vote when you are present at a WYCA meeting, committee or sub-committee meeting and have a disclosable pecuniary interest in any matter to be considered at the meeting which is registered in WYCA's register of interests, you will require a dispensation. The dispensation will not apply in any circumstances in which you may stand to make a personal financial gain or loss from the matter.
